Subject: Motor Vehicle Registration - Muscogee (Creek) Nation

In order to assist you and our Tribal citizens in perfecting a lien on any vehicle loans the following is being provided for your information.

Liens on vehicles owned by enrolled members of the Muscogee (Creek) Nation may be filed with the Muscogee (Creek) Nation tag office.

We will accept the Oklahoma Tax Commission FORM LEF-OK and we will forward the perfected Tribal title back to you with the remaining copies of the Lien Entry form for your records and distribution to owner.

The fee for such liens is ten dollars (\$10.00), made payable to Muscogee (Creek) Nation.

If your institution repossess a vehicle owned by a Tribal citizen, in order for you to obtain title, it will be necessary for you to file a Muscogee (Creek) Nation Repossession Affidavit, the fee for this service is ten dollars (\$10.00).

You should contact your attorney for a determination of whether to go to Tribal or State Court for repossession of vehicle. Muscogee Nation Tribal Court may be reached at (918)758-1412.

Upon receipt of a properly completed form, with appropriate notary of signature and supporting documentation, a repo title will be issued to your institution.

In order that no back taxes are assessed, the state of Oklahoma requires that when a vehicle with a Tribal license tag is transferred to the State a certified copy of the Certificate of Degree of Indian Blood, a certified copy of a Tribal Enrollment card, or a certificate of Tribal enrollment be attached.

If you do not have a copy of the membership information, you must request it when your affidavit is submitted.

REQUIRED SUPPORTING DOCUMENTATION

The repossessing lender must provide the following documentation in order for the Repossession Application to be approved:

- A. Properly completed Repossession Affidavit.
- B. Actual or certified copy of chattel mortgage, conditional sales contract or other type security agreement.

NOTE: Contract must indicate the vehicle has been pledged as collateral and list a complete description of the unit along with a vehicle identification number.

- C. Copy #3 and Copy #4 of the Lien Release form. If more than one (1) lien holder, the following is also required:
 - 1. A Copy of letter from the repossessing lender notifying the second lien holder of the intent to repossess.
 - a. Letter must be dated at least ten (10) days prior to the date the repossession affidavit is processed by the Muscogee (Creek) Nation Tax Commission.
 - b. The post office receipt and the return receipt (green card) signed by the second lien holder is required as proof of mailing.
 - 2. If the second lien holder is making application for a repossession title, Copy #3 and Copy #4 of the lien releases from the first lien holder is required.
