We are pleased to announce that in accordance with NCA 07-068, this year's Children's Mvskoke Language Camp is a 3-day camp that is being extended to students who are entering the 1st grade thru 6th grade. Students must be enrolled Creek citizens and those who have the desire to learn the Basic Mvskoke Language. The day camp will be held at the Claude Cox Omniplex in Okmulgee, OK. *******The first 30 Students will be accepted. (First Come First Serve!)***

These are the following guidelines that we need for you to discuss with your child(ren).

BEHAVIOR:

- Must obey all rules.
- Be respectful to everyone and everyone's property.
- Students must stay within the Claude Cox Omniplex boundaries at all times.
- Students must comply with the cell phone rule. **(No cell phones or electronic games during class or activity time).**

SAFETY:

- Report any illness or injury to a nurse or staff member immediately.

PERFORMANCE:

- Have a positive attitude and display good sportsmanship.
- Participate and put your best efforts into all activities.
- Speak and attempt to learn the Mvskoke Language as much as possible.

REQUIRED ATTIRE:

- Name tags must be worn at all times.
- Correctly fitting clothing: t-shirts, no spaghetti straps, shorts (one inch above knee only), capris and sneakers.
- No sagging jeans or shorts, no expensive personal items.

***Students should arrive at 8:00 am daily.**

***Students will be ready for pick up Wednesday, Thursday, and Friday at 4:00 p.m. daily.**

***Parents (Guardian) MUST sign student in and out daily.**
