Shall assess children's performance in all content areas (social, emotional, physical, intellectual, motor skills).</li> <li>5. Shall plan formal parent/teacher conferences twice a year and if needed more frequently.</li> <li>6. Shall work with parents of Special Needs children to get referred if needed and be able to assist with getting information needed.</li> <li>7. Shall complete and submit all necessary information and reports to the immediate supervisor in a timely manner.</li> <li>8. Serve meals and snacks to the children and eat family style with children in the classroom.</li> <li>9. Under direction of the Supervisor, shall confer with parents and all interested parties regarding the centers activities, policies, and enrollment procedures.
